- 3. The contract for this project will cover the existing leak located on the Southwest Corner of the building. This is the only area that will be covered at this time.

The intent of this solicitation however is to also cover future leaks of the same nature for a maximum period of 5 years from the date of the contract.

There are approximately 20 locations around the building where there is a potential for the same method of repair in the event future leaks occur.

This contract will cover a maximum of a 5-year period with an option to cancel by giving a 90-day notice by either party.

The Bid Form is being revised to accommodate future years.

There shall be no guarantee of future work after the completion of this initial project.
